WHY THIS SERIES?



How and Why did God design “speciation”: God, in His infinite wisdom, have created living organisms with incredible **embedded capability of producing off springs with different characteristics** (genes) yet the same DNA (kind). For example, a single human couple offspring genes are one out of 10^{1064} **possible variations**. Compare this number to 10^{80} , the estimated number of particles in the seen universe. This vast variety is enabled by the **huge number of gene (the building block of the DNA) variations**. This capability enables **living organism to adapt to changing environment**. These changes are **controlled by Epigenetics** which choses the right genes within the parent's DNA contributed halves. 



These used to be claimed percentage similarities were inflated because large part of the human DNA, and generally different living organisms, was considered **erroneously junk DNA** and therefore do not count. Even if this was correct it doesn't mean the difference is trivial. **1% DNA difference account for 30,000,000 different nucleotides.** This is an incredible difference when we know **that just 3 different nucleotides is fatal.**

Recent accurate studies showed the difference to "our closest relative" is not less than 30%. Evolutionists consider a difference more than 1% **EXCLUDES** the possibility of common ancestor, how much more for 30%?.
